NOTICE OF RACE

1 RULES

1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing* and the Class Rules

1.2 The Yachting New Zealand Safety Regulations Part 1 shall apply.

1.3 Racing rule A4.1 will be changed to 'a boat starting later than 10 minutes after starting signal will be scored DNS'
Racing Rule 61.1 (a) (2) will be changed so that P class, Starling & optimist boats are not exempt from displaying a red flag.
Racing rule 41 will be changed to add clause (f) TYPBC patrol boats may assist in the form of coaching during racing
Racing rule 27.1 will be changed to no later than the Preparatory the race committee signal boat will display the course number.
The changes will appear in full in the sailing instructions. The sailing instructions may also change other racing rules.

1.4 For protests where only a Rule of Part 2 is alleged to have been broken arbitration hearing will be offered prior to any formal hearing.

2 Boats may be required to display advertising chosen and supplied by the organizing authority.

3 ELIGIBILITY AND ENTRY

- 3.1** The series is open to all boats of the centreboard classes.
- 3.2** Eligible boats may enter by completing the entry form available at registration and payment of an entry fee of \$40 and \$30 for each additional sailing family member. A day entry of \$15 may be paid with the entry form on any race day.

Two handed boat entry fee is \$55 per boat.

- 3.3** To be eligible to compete in this event each competitors shall be a financial member of a club recognised by the competitor's national authority.

4 SCHEDULE

- 4.1** Registration:

Sunday 20th May 2018 From 0915hrs at the TYPBC.

Race Day 2 Sunday 17th June 2018 at 1030hrs at TYPBC

Race Day 3 Sunday 1st July 2018 at 1030hrs at TYPBC

Race Day 4 Sunday 15th July 2018 at 1030hrs at TYPBC

Race Day 5 Sunday 29th July 2018 at 1030hrs at TYPBC

Race Day 6 Sunday 12th August 2018 at 1030hrs at TYPBC

Race Day 7 Sunday 26th August 2018 at 1030hrs at TYPBC

- 4.3** **Racing Schedule**

The number and content of races will be determined by the race committee.

Details of the day's racing will be advised to competitors at each day's briefing.

The scheduled time of the warning signal for the first race on each race day will be 1125 hours.

Back to back races will be scheduled.

No races shall be started after 1530 hours.

- 4.4** Races may be postponed, cancelled or abandoned by the Race

Committee or may be rescheduled to a later date.

5 MEASUREMENTS

Measurement is not required but each boat may be required to submit proof of holding a valid measurement or rating certificate.

6 SAILING INSTRUCTIONS

The sailing instructions will be available at registration.

7 VENUE

7.1 Is the Tauranga Yacht & Power Boat Club (inc). At the end of Sulphur Point Tauranga.

7.2 Racing Area is the inner Tauranga Harbour.

8 THE COURSES

The courses will be windward/leeward or triangle/windward/leeward. Alternative or harbour courses may be described at each day's briefing.

9 SCORING

9.1 The Low Point System of Appendix A will apply.

9.2 2 races are required to be completed to constitute a series.

- 9.3**
- (a) When fewer than 6 races have been completed, a boat's series score will be the total of her race scores.
 - (b) When from 6 to 9 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.
 - (c) When from 10 to 13 races have been completed, a boat's series score will be the total of her race scores excluding her two worst score.
 - (d) When more than 16 races have been completed, a boat's series score will be the total of her race scores excluding her three worst score.

10 SUPPORT BOATS

Support boats shall be registered with the organising authority at registration.

11 LAUNCHING

Unless otherwise directed by the Organising Authority, all competing boats and equipment shall be launched and retrieved from in front of the TYPBC club house.

12 RADIO COMMUNICATION

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

13 PRIZES

Prizes may be awarded at the conclusion of the series.

14 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See rule 4 Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta,
